## Training registry of the Modern Business Services sector

## WORKSHOPS TRAINING

### The next stage of project implementation

The workshops will implement a range of learning outcomes related to the use of VR technology in education. Participants will work with VR equipment, using a dedicated application in a virtual environment. In this way, they will learn about the possibilities of this technology in teaching, and at the same time develop soft competencies - such as communication and teamwork. The classes will be conducted in a train-the-trainer formula, which means that participants will not only learn new tools, but also how to pass on the acquired knowledge on their own.

From the perspective of the project, the workshops also have a testing function - they are an opportunity to see how the new register of training services, through which the enrollment and implementation of classes will be conducted, works. Therefore, the participants' involvement will be treated as a form of User Acceptance Testing (UAT), crucial for further implementation of the solution.

In turn, for participants, the workshop is an opportunity to gain practical experience in working with VR technology in education and develop soft skills in an engaging and modern way. Microcredentials in the form of digital badges, confirming the acquired competencies, will be provided for participation and realization of learning outcomes.

The workshop will be implemented from 01.05-31.07.2025.

In the last days of April, at the headquarters of the Malopolska Regional Development Agency S.A. (MARR) in Krakow, the third stationary meeting of project partners was held. The event lasted from April 28 to 30 and brought together representatives of organizations involved in project work from Poland, Italy and Cyprus.

The main highlight of the program was an intensive training course on the use of VR tools and the practical application of the functionality of the created registry. The purpose of the training was to prepare the partner teams for further implementation of innovative solutions, which are a key element of the project.

The training was the first step towards the full implementation of the registry, which is intended to become a publicly available tool to support education and the development of digital competencies in professional and educational settings.
